To Whom It May Concern:

This letter is a courtesy notice to let you know PG&E will need to enter your property in August 2015 to install Piezometer's and/or test wells. These wells will be used to determine ground water levels and dewatering requirements needed for the project.

The Piezometer's are 1-inch in diameter and will be installed along field borders or next to dirt roads. This type of construction does not produce drill cutting other than the soil removed from the drive point. HDD sites will require a test well using an auger rig and will be 5 to 6-inches in diameter. Impact to your property will be minimal. Once the Piezomter/test well has been installed it will remain in place until the pipeline is constructed
