This ballot may be used to express either support for or opposition to the proposed assessment district. In order to be counted, this ballot must be signed by an owner or, if the owner is not an individual, by an authorized representative of the owner. The ballot must then be delivered to SAFCA's Clerk either by mail or in person, as follows:

MAIL DELIVERY:

If by mail, place in the postage-paid return envelope provided, and place in the mail not later than one calendar week prior to June 13, 2016. Mailing later than this deadline creates the risk that the ballot may not be received in time to be counted.

PERSONAL DELIVERY:

If in person, deliver to the Agency Clerk at any time up to 1:00 p.m. on June 13, 2016 at the Clerk's office at 1007 7th Street, 7th Floor, Sacramento, CA. You may also deliver the ballot at, and prior to the close of, the protest hearing, which is scheduled to commence at approximately 1:00 p.m. on June 13, 2016 at the meeting place of SAFCA's Board of Directors, which is the chambers of the Sacramento City Council, 915 I Street, Sacramento, CA 95814.

However delivered, the ballot must be received by SAFCA's Clerk prior to the close of the public hearing (whether on June 13, 2016 or a later continuation date) in order to be counted.
