Big Barn wind damage repairs on addition overhang at West side of barn. North West section which has blown off, Approximately 10FT X 60FT area. Remove remainder of damaged wood and metal sheet pieces and dispose of. Add 10 new D.F 2" X 6" X 10Ft rafters using Simpson Strong-Tie HU 26 Hangers. Furnish and install 240FT of new D.F 2" X 4" sheathing boards over new wood rafters.

Secure all new wood sheathing boards, using Simpson Strong-Tie A23 Galvanized metal plates with #9, 1 1/2" wood screws.

Furnish and install new 26 gauge galvanized metal roof sheets to match original design, using 1 1/2" metal to wood screws 6" on centers over new sheathing for 110 mph wind uplift specification.

Add 21, 2" X 6" 10FT D.F. wood rafters between existing rafters using Simpson String-Tie Hu26 Galvanized metal hangers.

Add 110FT of 2" X 4" D.F. wood sheathing boards.

Secure all new sheathing boards and existing sheathing boards, using Simpson Strong-Tie A23 Galvanized metal plates with #9, 1 1/2" metal to wood screws. Add 9 new 1 1/2" metal to wood screws on each existing metal sheet to achieve 110 mph wind uplift specification.
