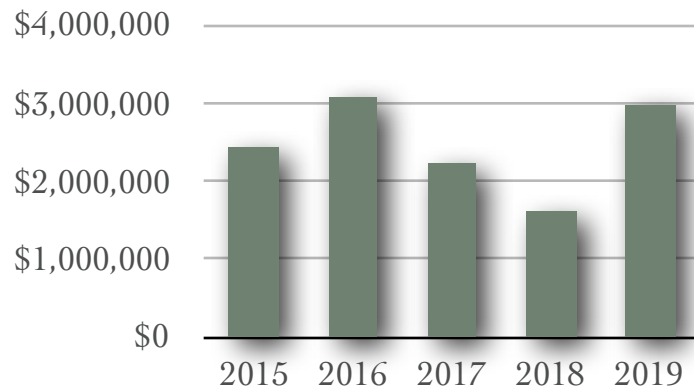

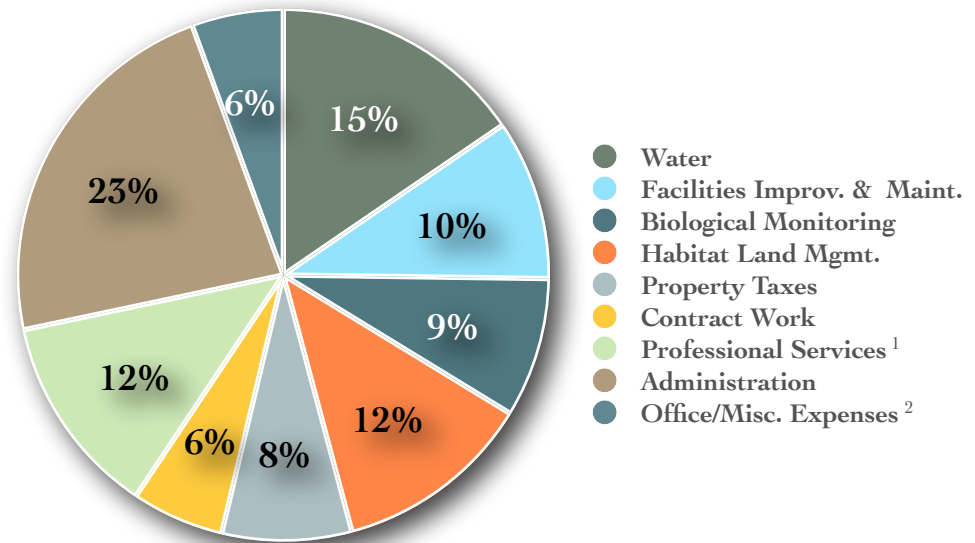
Non-Endowment Revenue Analysis

2 – **Liabilities** – As the managed marsh construction component follows and lags acquisition, approximately 3.7% of the 25% managed marsh target remains in process and is not yet completed. Accordingly, the Conservancy will need to construct managed marsh on approximately 140 acres. At an average cost of \$9,000 per acre of managed marsh construction costs, this results in an on-going managed marsh R&E obligation of approximately \$1,265,441.

UPDATE: Approximately 90 acres of Bianchi West are planned for managed marsh construction in 2021.
